**DESCRIPTION :**

In order to comply with new SOx emission regulation published by IMO(International Maritime Organization),we would like to introduce ISOCC(IMO Sox Compliance Charge) to replace current LSS/L, LSS/D.

**IMO Regulation:**

The International Maritime Organization (IMO) will enforce a new 0.5% global Sulphur cap on fuel content worldwide from January 01, 2020, further reducing the Sulphur content from the present 3.5% limit. To reflect the increased cost for compliance with this new regulation, all the ocean freight shall be subject to ISOCC (IMO SOx Compliance Charge) that will go into effect on January 01, 2020.
