**DESCRIPTION** :

In order to comply with the market and reflect the fluctuation of bunker price in time, IAD would like to modify ISOCC(IMO SOx Compliance Charge) calculation formula from quarterly to monthly review with effective from JUL/01/2020 onwards(on board date) under F Trade as below.

IMO Regulation:

The International Maritime Organization (IMO) will enforce a new 0.5% global sulphur cap on fuel content worldwide from January 01, 2020, further reducing the Sulphur content from the present 3.5% limit. Unless otherwise specified, all rates governed by F trade shall be subject to "IMO SOx Compliance Charge ("ISOCC")".

Remarks: ISOCC will be monthly reviewed by actual refueling ports.
