DESCRIPTION :

In order to comply with new SOx emission regulation published by IMO (International Maritime Organization), we would like to introduce ISOCC (IMO Sox Compliance Charge) to replace current LSS/L, LSS/D.

IMO Regulation:

The International Maritime Organization (IMO) will enforce a new 0.5% global sulphur cap on fuel content worldwide from January 01, 2020, further reducing the Sulphur content from the present 3.5% limit. Unless otherwise specified, all rates governed by **F trade** shall be subject to "IMO SOx Compliance Charge ("ISOCC")" and will go into effect on November 01, 2019.
